	SUBJECT: Management Advisory Report - Roofing Product at United States Postal Facilities (Report Number FA-MA-00-002)
	This report presents the results of our review of an Office of Inspector General (OIG) Hotline allegation concerning a newly installed roof of the Houston Processing and Distribution Center. Specifically, the complaint alleged that six months after the installation of a new roof, it was replaced for an additional \$1 million.
Results in Brief	A preliminary review disclosed that the hotline complaint was not accurate. Specifically, a general contractor had installed a new roof at the Houston Processing and Distribution Center using defective roofing product; however, the roof was replaced under warranty at no cost. We offered management two suggestions to ensure that the Postal Service does not incur cost for repairing roofs where the defective roofing product was used. Management agreed with our conclusion and has planned corrective actions that are responsive to our suggestions.
Objective, Scope, and Methodology	The objective of the review was to determine the validity of the hotline complaint. We conducted interviews with the Houston, Texas manager of Administrative Services, and the Memphis Facilities Office project manager. We also reviewed contract files and other relevant documents. This review was conducted from May 1999 through February 2000, in accordance with the President's Council on Integrity and Efficiency, <u>Quality Standards for</u> <u>Inspections</u> .

Defective Roofing Product Observations	The review confirmed that in June 1995 a general roofing contractor installed a new roof on the Houston Processing and Distribution Center. OIG discussions with the Administrative Service Office and the project manager revealed that Postal Service staff had conducted several inspections of the center's roof and were aware of problems with the roofing product that caused water to infiltrate areas of the roof. Postal Service personnel negotiated with the roofing product distributor, who agreed that the use of a defective roofing product caused the problem. As a result, the roof was repaired by the distributor and was covered under the warranty, at no additional cost to the Postal Service.
	The contract to repair the roof included a twenty-year no dollar limit gold shield roofing system guarantee, effective February 1998. This guarantee warrants repairing any leaks that are attributed to defective workmanship and/or materials.
	The distributor's database revealed that over the past decade, roofing contractors used the same type of product to repair over five hundred postal facilities. More importantly, further analysis by the OIG revealed that between 1994 and 1999, the roofing product was used on at least 125 postal facilities nationwide. Without further complaints or roof inspections, the Postal Service cannot determine which of these facilities would be affected by the defective-roofing product. Attached is a list of the 125 postal facilities (Appendix A), in which the defective roofing product may have been installed.
	To ensure that the Postal Service does not incur costs to repair roofs where the defective roofing product was used, Postal Service management should notify the managers of the 125 facilities of the defective roofing product and advised them of related warranty information.
Suggestions	We suggest that the vice president, Facilities direct the manager, Major Facilities Office to:
	 Issue a Customer Alert Notice to managers of the 125 postal facilities, where the defective roofing product was used to advise them of potential problems associated

	with this product and the availability of repairs under warranty.
	 Seek recovery from the roofing product distributor any costs already incurred to repair roofs on facilities where the defective roofing product was used.
Management's Comments	The vice president, Facilities, indicated agreement with our suggestions and stated that the report will be forwarded to the eleven Facilities Service Offices, requesting that they pass the information to the respective area offices for appropriate action. Management's comments, in their entirety, are included in Appendix B.
Evaluation of Management's Comments	Management's comments are responsive to our suggestions and the planned actions should ensure that the Postal Service does not incur costs to repair roofs where the defective roofing product was used.

We agree with the conclusion in the management advisory report dated Feb. 14, 2000, referenced above. In response, we will forward this report to the eleven Facilities Service Offices when it is finalized and ask them to forward the information to the respective Area offices for appropriate actions as necessary. Based on the square foot information provided, it appears that most of these were small repair and alteration projects that are under the purview of the Administrative Service Offices.

Based on our past experience, we believe this is a respected manufacturer with a proven tract record. While it is possible that the defective roofing product was installed in some other projects, it is also highly possible that, this specific incident is related to the specific batch or run of material that was found to be bad. We would recommend that the manufacture of the product including the specific product name, batch or run of the material be stated in the report, as well as a confirmation that it was used on the 125 projects listed. Following is suggested to be added to the final report:

'The roof installed was a Modified Bitumen roof with DynaKap membrane provided by Schuller/Johns Manville Roofing System. The new roof was substantially completed in June 1995, due to manufacturer material defect; it then was repaired/overlaid by Schuller System in February 1998 at no cost to USPS. A 20 -Year No Dollar Limit Gold Shield Roofing System Guarantee was reissued starting the roofing warranty from February 1998.'
